

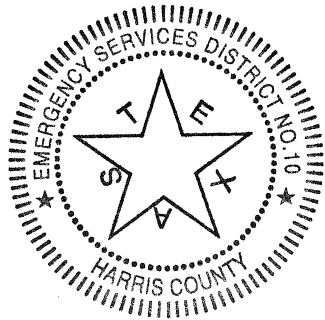
**NOTICE OF PUBLIC MEETING**

13. To review, discuss and take action regarding adoption, amendment and explanation of District policies, procedures and standard operating guidelines.
14. To review, discuss and take action on submittals received from the District Commissioners seeking compensation as permitted by Texas Health & Safety Code §775.038 (a-1).
15. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.0735.
16. To review, discuss and take action on any District matters which need to be included on the next agenda for the August 2022 meeting.

17. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel.
18. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
19. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
20. To review, discuss and take action on any personnel or real estate matters.
