1. Call meeting to order, roll call and establish a quorum.
2. To receive public comment.
3. To propose the District 2026 Budget.
4. To propose the District 2025 Tax Rate.
5. To schedule a public hearing regarding the District's 2025 tax rate and the date of the meeting to adopt.
6. To review and take action on matters relating to an election to be held on November 4, 2025:
 - a. Approve an Order of Election under Texas Tax Code Section 26.07.
 - b. To review and take action to hold an election jointly with other jurisdictions.
 - c. To review and take action to contract with Harris County Elections Office for election services.
 - d. To consider and take action on such other Orders, Resolutions and related matters as required or appropriate to call for the District election.

6. Para repasar y actuar en relación a asuntos relativos a una elección a celebrarse el 4 de noviembre de 2025:
 - a. Aprobar una Orden de Elección bajo la Sección 26.07 del Código Tributario de Texas.
 - b. Para repasar y actuar en relación a la celebración de una elección conjunta con otras subdivisiones políticas.
 - c. Para repasar y actuar para contratar servicios electorales con la Oficina Electoral del Condado de Harris.
 - d. Par considerar y actuar sobre tales otras órdenes, resoluciones y asuntos pertinentes que sean requeridas o apropiadas para convocar la elección del Distrito.
6. Duyệt xét và quyết định các vấn đề liên quan đến một cuộc bầu cử sẽ được tổ chức vào ngày 4 tháng Mười một, 2025:
 - a. Phê chuẩn Lệnh Yêu Cầu Tổ Chức Bầu Cử theo Bộ Luật Thuế Vụ Texas Mục 26.07.
 - b. Duyệt xét và tiến hành tổ chức một cuộc bầu cử cùng với các khu vực pháp lý khác.
 - c. Xem xét và tiến hành ký hợp đồng với Văn Phòng Bầu Cử Quận Harris cho các dịch vụ bầu cử.
 - d. Xem xét và thực thi các Lệnh, Nghị Quyết khác nói trên, và các vấn đề liên quan theo quy định hoặc khi thích hợp để yêu cầu tổ chức cuộc bầu cử của Cơ Quan.
6. 審核並採取相應行動關於 2025 年 11 月 4 日舉行的選舉相關事項:
 - a. 通過選舉命令根據 Texas 州稅法第 26.07 條。
 - b. 審核並採取行動與其他管轄區舉行聯合選舉。
 - c. 審核並採取行動關於與 Harris 縣選舉辦公室就選舉服務簽訂合約。
 - d. 按舉行本區選舉之必要或恰當的條件，考慮並採取行動關於其他命令，決議案及相關事項。
7. To receive the District's financial reports and take any action related thereto.
8. To review and take action on financial matters of the District and pay District bills.
9. To review, discuss and take action on submittals received from the District Commissioners seeking compensation as permitted by Texas Health & Safety Code §775.038 (a-1).
10. To receive a report from the District's sales tax consultant.
11. To review, discuss and take action regarding any matters related to the District's budget.
12. To approve the Minutes of prior meeting(s).
13. To receive Administrative and Operational Reports from District staff.
14. To review, discuss and take action on any needed repairs, replacements and improvements related to the operation of the District's equipment, apparatus or facilities.
 - a. Radio purchases through Northwest Communications
15. To review, discuss and take action regarding District construction projects including the review and approval of pay applications, including but not limited to the District's Logistics and Station 36 expansion projects.

16. To review, discuss and take action to select a lender to provide financing for the District's apparatus acquisition of the following:
 - a. One (1) new Velocity Aerial Apparatus;
 - b. Four (4) new Velocity Pumper Apparatus;
 - c. Equipment for those apparatus; and
 - d. The refurbishment of a 2010 Velocity Rear Mount Platform.
17. To authorize District Board Officers to execute any and all necessary documentation related to lender financing awarded for the District's apparatus acquisition.
18. To review, discuss and take action on submittals by the Department of thirty (30) day advance request(s) for necessary purchases related to the provision of emergency services.
19. To review, discuss and take action on approval of expenses related to upcoming training classes for the District Commissioners, Department Officers, Administrative staff and Department personnel.
20. To review, discuss and take action regarding adoption, amendment and explanation of District policies, procedures and standard operating guidelines.
21. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.0735.
22. To receive a legislative update from District counsel.
23. To review, discuss and take action on any District matters which need to be included on the next agenda for the August 5, 2025 meeting.
24. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel.
25. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
26. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
27. To review, discuss and take action on any personnel or real estate matters.
28. Announcements by the Commissioners or Chief of the Department.
29. Adjournment.
